

1. For Measure Y, Cannabis Business License Tax, there were twelve (12) voting precincts including absentee precincts established for the purpose of holding said election, consisting of the regular election precincts established for holding general, state and county elections.
2. For Measure Y, Cannabis Business License Tax, the number of registered voters in the City of Patterson was 9255; and of the 9255 registered voters in the City, there was a voter turnout of **5718** (Ballots Cast in the voting precincts) and a voter turnout of **5718** (Ballots Cast) for a total of 61.78 Percentage Turnout.
3. That at said Consolidated Statewide General Election held on November 6, 2018, Measure Y known as the “Cannabis Business License Tax” of the City of Patterson was approved by the voters as follows:

4 law.
- 5 5. That there were voting precincts established for the purpose of holding said election,
6 consisting of precincts established for holding general, state and county elections.
- 7 6. For the position of Mayor at Large, the whole number of registered voters in the City
8 of Patterson was 9255; and of the 9255 registered voters in the City, there were 5718
9 Ballots Cast in the established twelve (12) voting precincts for Mayor; or 61.78
10 percent.
- 11 7. For the position of Council Member, District B, the whole number of registered
12 voters in the City of Patterson was 2639; and of the 2639 registered voters in the City,
13 there were 1641 Ballots Cast in the established two (2) precincts for this District; or
14 62.18 percent.
- 15 8. For the position of Council Member, District D, the whole number of registered
16 voters in the City of Patterson was 1965; and of the 1965 registered voters in the City,
17 there were 1182 Ballots Cast in the established three (3) precincts for this District; or
18 60.15 percent.

20 and the number of votes given at each precinct to each person, and the number of
